4-H Community - Volunteer Service Activities Scholarship Guidelines



Description:

A volunteer service activity is defined as any volunteer (non-paid) service performed for our community or state which proves beneficial to others and is meeting a specific need of the agency being served.

Guidelines:

- 1. Scholarships will be worth \$40.00 to be used towards any 4-H event such as camps, retreats, conferences, or lock-ins. 4-H youth may also have the option to donate their scholarship to the 4-H club of their choice if they cannot use the scholarship personally.
- 2. The complete amount of hours must be earned before a scholarship can be awarded.
- 3. All junior or senior 4-H youth will receive the same amount of hours/money for finishing the service activity.
- 4. Hours or scholarships cannot be carried over year after year.
- 5. Hours must be earned during the July 1 June 30 calendar year.
- 6. A 4-H youth may perform an activity not list on the Suggested 4-H Volunteer Service Activities List, if first approved by the Extension Office.
- 7. Scholarships are non-transferrable.
- 8. Parents/Guardians are responsible for all transportation needed for the activity.
- 9. An official copy of all 4-H hours will be kept in the Mercer County Extension Office.
- 10. At the time of service, each 4-H youth is required to have service log form sign by the sponsor before any hours will be credited.
- 11. A list of suggested activities will be kept in the Mercer County Extension Office in 4-H Community-Volunteer Service Activities Book, and you may request a copy.
- 12. Volunteer Service work may only be done at non-profit organizations/groups.
- 13. Participant must be enrolled in 4-H.
- 14. Community Service Scholarships are limited to two scholarships per person =\$80.00.
- 15. Community Service is defined as: work done free of charge for someone or some group in the community who cannot reimburse the 4-H youth for their services. Also work for any non-profit group
- 16. All community service hours must be completed and submitted to the Extension Office 10 days prior to the activity/event
